Guidance on Outbreak Management

Public Health Emergency Operations Centre (PHEOC) in collaboration with the ECU have developed the <u>Covid-19 Case and Outbreak Management Guidelines</u> for Tasmanian ECEC Settings.

This document will assist service providers to determine, notify, manage, and resolve an outbreak at your service.

Masks & Rapid Antigen Tests for Children

The government will be providing RATs for children attending services. These kits will be distributed by Public Health and the allocation will cover all service types in your organisation.

How many RATS will we receive?

The number of RATs has been calculated using Commonwealth Government data for the November 2021 period. Attendance figures for this period better reflects your service capacity.

Will we receive a RAT for each child?

RATs will not be provided for children under two years of age. PCR tests are more suitable for use with children of this age group.

Critical Worker Exemptions

Education and care/childcare services are included in the temporary exemption framework for critical industries. This means essential staff can be exempt from the

quarantine requirement for close contacts if they are identified as critical workers.

When can ECEC staff apply?

Staff who are close contacts may only qualify if the ECEC setting is facing a critical shortage of staff due to COVID-19 isolation/quarantine measures.

Registration must be made by the employer through the <u>Coronavirus website</u> and is subject to restrictions.

Public Health will notify the ECU of registrations.

Gap Fee Waiver requirements

The Australian Government, Department of Education, Skills and Employment (AGDESE) has revised their requirements to qualify for the gap fee waiver.

The requirement for written acknowledgement from public health or the ECU is no longer necessary.

Ventilation in ECEC settings
