GENERAL TOPICS

Processing of Notifications and Applications

The ECU will trial a new approach to streamline our review and approval process. Notifications and applications you submit will be allocated to our Authorised Officers (AOs). Allocations will be made based on when we have received your submission rather than being automatically allocated to your point-of-contact (POC) officer.

Any of our AOs may contact you asking for further information or additional documents in relation to your submission. This process aims to spread workload more evenly between our staff and improve our response time.

We recommend your submissions contain sufficient detail with supporting documentation. This will help our AOs make an assessment quickly.

For example, a serious incident notification involving an injury to a child will require details:

- about the equipment involved,
- on supervision practices implemented during the incident such as:
 - o the location of the closest educator, and
 - o the activity leading up to the injury.

Your POC Officer is available to answer your queries and will continue to conduct monitoring visits at your service.

Changes to Child Care Subsidy (CCS)

CCS rates will <u>increase</u> from 11 July 2022 to account for adjustments in the Consumer Price Index. Find out how combined families can get the Higher CCS.

COVID-19 TOPICS

Post-emergency declaration advice

Since I July 2022, the Public Health (PH) Emergency Declaration in relation to COVID-19 in Tasmania is no longer in effect.

To assist you in this transition, PH has developed several best practice guidelines available <u>here</u>.

These factsheets have direct relevance to our sector:

- Management of COVID-19 after the Public Health <u>Emergency</u> – this provides a summary of what will continue and what will be changing.
- Best Practice for Vaccination this guidance note contains important information about conditions employers must meet if they wish to require COVID-19 vaccination at their workplace.
- The <u>Best Practice Facemasks</u> guidance note outlines when facemasks are recommended and why they are important.
- Best Practice for Early Childhood sector —
 specifically for the ECEC sector and provides a
 summary of what COVID-19 requirements will
 remain in place with tips on how to continue using
 your COVID-19 safety plans.

COVID-19 support extended to June 2023

The Australian Government will extend the following COVID-19 measures for the ECEC sector until 30 June 2023:

Absences

Families are eligible for at least 52 absences in the financial year with an option to request for more. The exceptions to the 'absences before and after care rule' have also been extended for enrolments that start or end between I December 2021 and 30 June 2023.

Gap fees

Until 30 June 2023, you can waive the gap fee and continue to receive Child Care Subsidy (CCS) if a child is unable to attend care for one of three reasons listed on the <u>AGDoE</u> website.

COVID-19 FAQs

The following FAQs have been updated to align with current advice from Public Health:

- If a child is a close contact, must they undergo testing?
- How long will the vaccination mandate be in place for?



- Do educators in an early childhood education and care setting need to wear masks?
- Where do I go for information about pandemic plans?
- Can unvaccinated ECEC staff members return to work in the ECEC sector under the same circumstances prior to the vaccination mandates in place?
- Who is responsible for notifying Public Health of a child's positive test?
- What must a service do if staff/children who were at their facility (including within the last 48 hours) test positive?
- If a child is a close contact, must they undergo testing?
- What are the isolation/quarantine requirements for close contacts?

 The general Public Health Hotline remains available to others outside the sector.

Public Health's emails and phone lines will be monitored at the following times:

- 8am to 8pm on weekdays
- 8am to 5pm on weekends
- After 5pm, the CNC mobile will be monitored by an on-call CNC.

The ECU will continue to share relevant information from Public Health to the sector without providing health advice.
