The ECU SRG met in December 2022. The information below reflects the discussion and outcomes from the meeting:

I ECU Staffing - Update

Vanessa Morris, Acting Manager - Policy and Engagement, is on secondment to the Department of Premier and Cabinet (DPAC). Bryan Cheong has recently left the ECU. Elli Liddell has been appointed as Policy and Communication Officer on a permanent basis. Recruitment is currently underway for a Project and Administration Officer.

We look forward to Trish Hamilton, Regulatory Officer and Estelle Clerk, Manager – Policy and Engagement returning to the ECU in the coming months after undertaking extended leave in 2022.

2 Universal access to early learning for 3-year-olds - Update

Tim Denby, the Assistant Director, for Strategic Policy and Projects, Department for Education, Children and Young People provided an update on the early learning for 3-year-olds initiative.

In August 2022, the Premier of Tasmania announced the intention to provide universal access to early learning, in the year before kindergarten, for every 3-year-old child.

The Government's approach to designing and implementing universal access will be co-designed with the Early Childhood Education and Care (ECEC) sector, families and other stakeholders. More detail on this approach will be provided early in 2023.

Please note, the Premier's announcement to expand access to early learning for 3-year-olds is different to the planned expansion of *Working Together*, although they are related and complementary initiatives. *Working Together* is a very targeted program to improve access and equity for children and families requiring additional support to engage with early learning. Access for 3-year-olds is a broad universal policy relating to all children in the cohort.

It is important to note expansion of early learning for 3-year-olds is not a 'back door' way to introduce a lower school starting age. It is about providing voluntary access to early learning for children to support children's learning and development. The approach will:

- Be designed collaboratively with the ECEC sector and other stakeholders
- Not be a one size fits all and will be responsive to the needs of local communities
- Not legislate changes to school starting ages
- Expand access through ECEC settings as the preferred provider wherever possible.
