The ECU SRG met in March 2023. The information below reflects the discussion and outcomes from the meeting:

I ECU Staffing - Update

Manager of the ECU, Vidhya Chelliah, will be continuing the important work she is doing in the national policy space and in leading the Closing the Gap work for DECYP. Janelle Brennan continues to Act as Manager of the ECU until 30 April 2023. An Expression of Interest (EOI) will open shortly to backfill the Manager position for a I2-month period from May 2023. To ensure continuity in operational functionality and best support the sector, Charlotte Geeves is Acting Operations Manager - Assessment and Rating. Petra Ambrosiussen is Acting Regulatory Officer during this period.

Estelle Clerk, Policy and Engagement Manager, has returned to the ECU after a period of extended leave. Annette Bourke, Administration Officer, has retired. Daisy Bacon has been appointed in the role of Project and Administration Officer.

Recruitment for a Project Manager - Education and Care Workforce Strategy, as well as recruitment for an Education and Care Assessor to cover maternity leave is underway.

2 Revised Assessment and Rating processes in 2023

From 2023 some Assessment and Rating (A&R) processes will be changing in Tasmania, in line with a revised national approach. This includes:

- Increased use of partial A&R visits (for services with a current 2018 NQS rating).
- Increased focus on service's quality improvement journey, including the QIP, as an ongoing process.
- Introduction of shorter notice periods for A&R visits (1-5 days).

A report will be provided to the Australian Government Education Minister at the end of 2023.
