Communities Tasmania Response to the Informal Kinship Care Review Recommendations

Communities Tasmania's response to each of the eight recommendations is outlined in the table below. All eight recommendations have been accepted.

Initiatives undertaken in response to the recommendations will fall under the banner of the 'Informal Kinship Care Program'.

On the 15 March 2021, the Government announced immediate funding of \$500k to begin implementation of initiatives under the Informal Kinship Care Program over the next 12 months. Support for longer term/ongoing initiatives will be considered through the 2021-22 State Budget process.

The Informal Kinship Care, Liaison and Support Pilot Program will be progressed immediately, including a dedicated Liaison and Support Officer in the North West through Mission Australia.

Communities Tasmania will also develop options for extending more existing Government programs to informal kinship carers. Communities Tasmania will also undertake targeted case reviews to examine decision making and promote greater clarity for informal kinship carers.

Other key initiatives include:

- New training opportunities for informal kinship carers;
- An information portal for informal kinship carers;
- Increased brokerage for the new Informal Kinship Care Program;
- Community based respite services for informal carers; and
- Extension of access to supports and concessions for informal kinship carers.

The Minister will write to relevant Government ministers and officials and advocate at a State and National level for continued advancement of recognition and support for informal kinship care.

The primary functions and responsibilities will involve a focus of overseeing and/or coordination in order to: Inform policy and practice within the ARL and Family Support Services through action learning and contributing to practice review, including information changes to the Children, Youth and Families (CYF) Practice Manual.  Recommendation 3: Expand the availability of training and awareness raising programs Expand the availability of existing training and awareness programs delivered by the community sector to informal kinship carers, to build capacity across an identified range of practices and capabilities that enhances coping mechanisms specifically for informal kinship carers, such as: Parenting and behavioural management training; Bringing Up Great Kids Program; Mediation, Conflict Resolution and Communication; and Leadership and mentoring training for members of voluntary support organisations to enhance peer support in managing complexities and relationships. 	 Accepted* Immediate funding for training will be provided to: expand the availability of existing training and awareness programs to informal kinship carers; and to build capacity across an identified range of practices and capabilities.

 Match funding levels to enable support groups or community support providers to access these programs and resources. 	
 Recommendation 4: Improve the availability of information and resource material for informal kinship carers Develop digital information that facilitates links to information to and from other agencies (state and federal) through an easy to access portal for informal kinship carers and support services. In the interim, provide one-off grants for voluntary kinship care support groups to compile and distribute a fact sheet and digital information that is reliable, easy to access and uses simple language for use by informal kinship carers, covering eligibility for financial assistance and services, access to service providers and peer group contacts; and undertake peer support and mentoring of informal kinship carers. 	 Accepted Digital information (including a fact sheet) will be developed that facilitates links to information to and from other agencies (state and federal) through an easy to access portal for informal kinship carers and support services. It is considered that an interim measure will not be required, instead Communities Tasmania will work with advocacy groups in the development of content for the digital resource.
 Recommendation 5: Review relevant Child Safety Service Client Files Undertake targeted audits and case reviews to examine the decision-making rationale of Child Safety Service cases where the classification of children in care with grandparents, from the same situation and same parents, may be presently both informal and formal. 	 Accepted Communities Tasmania will undertake targeted audits and case reviews to examine the decision-making rationale of CSS cases where there are formal and informal arrangements in place within the same kinship care household. Information will be developed based on the findings to provide informal kinship carers with the decision-making rationale. This information will be placed on the portal (Recommendation 4).
 Recommendation 6: Examine policy options to improve support 6A. Explore government policy options and definitions that might be available to improve access to informal kinship carers, who are the responsible adults and have primary care responsibilities to meet the needs of children in their care, to improve support in: Education and schooling; Health and professional counselling; and Household and travel expenses. 	 Accepted A resource within Communities Tasmania will explore options to improve access and support to informal kinship carers in: education and schooling; health and professional counselling; and household and travel expenses.
