Cr I, E 3 = further description haven't entered further than list. Needed more different examples of how to manage pig farms, no evidence of research across the board or examples of other farms

cr I, E 5 = elaboration on the table needed; good table but no discussion - there but not used in context, no analysis or interpretation

cr 3, E1 - put note on calendar and notes based on observations - scanned note book or a calendar with three columns

Cr 3 E 2 - more description or discussion

Cr 3 E 4 - doesn't follow through on analysis, more discussion and elaboration no 'why'

cr 3 E 5 they did discuss growth potential but needed more here, descrition of their p=improvements, some figures and analysis of what they needed to improve - more than a set discussion

cr 3 E 6 = more examples, show their gumtree ad, more detail, photos, more descrition - it calls for strategies NOT just strategy
