C3: Not a huge amount of information in there, sound but basic response across the board. covered all of the 4 dot points, a little bit of miss information. Not many connection to health status could have impacted their mark.

The question was an issue, terminology was unclear so it makes if difficult to look at this answer.

C7: the answer doesn't flow that well, spelling and grammar, good health language within the answer, reasonable response - paragraphs, flow was okay, acknowledging that C7 is difficult to assess. Time pressures and short answer is an issue. Sentence structure, typos, content and health language good.

The questions in the exam did not meet the Criteria 7 -this becomes very difficult to mark then in a reduced way.
