Moderation Details for Calibration - Sample 1

Sample I - What rating (or ratings) has the group assigned this sample?

ranged from C to A, with most giving an A-.

Sample I - What evidence supports the rating (or ratings) the group has given?

Student did not evaluate; there was explanation and enough analysis to award a B, but not enough evaluation to award an A. There was discussion that although data analysis is part of each part of an exam, there isn't an element that clearly assesses data interpretation within the criteria- only selection and explanation.

Moderation Details for Calibration - Sample 2

Sample 2 - What rating (or ratings) has the group assigned this sample?

ranged from C to B+

Sample 2 - What evidence supports the rating (or ratings) the group has given?

Some teachers scored 2 higher than I but others thought I was a better paper. Again, the student explained well in most cases, analysed in some but did not evaluate (for example, the footprint of Indonesia was not compared to Australia).

Moderation Details for Calibration - Sample 3

Sample 3 - What rating (or ratings) has the group assigned

ranged from C- to A, although the A was a clear outlier

Sample 3 - What evidence supports the rating (or ratings) the group has given?

Some questions (virtual water) were done at the A standard in terms on analysis, but others (overfishing) did not even reach the C standard (no selection of data); this range of achievements puts them in the low B/high C standard.

Moderation Details for Calibration - Sample 4

Sample 4 - What rating (or ratings) has the group assigned this sample?

this was the most consistent sample, ranging from t+ to C+.

Sample 4 - What evidence supports the rating (or ratings) the group has given?

There was enough knowledge demonstrated, and enough explanation, to give them a C; although there were some elements on which a C was not even achieved.

In general, there was consistency between the four markers in the North, with deviation of only + or - in all cases.

Advice to students to make sure they write enough to demonstrate whether they are at an A, B or C standard-
