Should we have simple y = 4 - 2x or y = -2x + 4? Should we show scale on a grid if so specify in the question or not have a grid.

Need to work on algebra skills and scatter plot and line of best fit problems. Devise tests that have all ratings available in sufficient quantity and coverage of the course. Standards for Criteria 4 does not cover all of the required content in the unit - Course requires an update to give a better group of standards to moderate on, (as well as course content). This was a big theme. Write clear questions of what the students is required to do either by algebra or calculator.
