E1, a solid attempt was made in selecting a range of technologies and techniques to develop and express their own ideas and designs in the journal but it was considered to be borderline B-/C+E3, a limited range of technologies and techniques to own studio practice was evidenced.E4, journal exploration and decision making was evident, displaying extended technique and identifying problems, closer to a B. Criterion 4;communicate ideas, emotions and information - elements 1-4General consensus was that this was a $C/C+E1-3$ Not enough annotation of selection of images for own work, not rigorous in their discernment of images and not enough adjustment of communication methods and styles in responding to minor changes.E1, not limited, but not a range of communication methods and styles to express ideas, emotions and information either. E3, limited description of artistic styles, genres and processes.



Discussion that some of the Elements were rated at BE5, limited conceptual development and expressive intentions conveyed after arrival on technique
