and ways forward you would like Curriculum Services to consider in relation to this course:

• Suggestions from teachers around wording of criteria and course structure were looked at but it was decided (Darren Perry) not to change in light of the current review of Year 9-12 Educational delivery. Discussions around potentially growing the HPE area in areas like sociology of sport and recreation. Other possibilities involve 30 and 60 hour module units may offer more timetabling flexibility.

• If there are elements of the course that need fine tuning that process will provide the opportunity to fix it, possibly in the next 12 months. Input from teachers will again be asked for.

• Teachers expressed frustration about the process of repeatedly identifying need for changes, but then feedback not being acted on. Ultimately TASC makes the final decision whether or not to act on teacher feedback that is fed through by Curriculum Services.

• The re-write for the HPE subjects was very rushed, so it was felt that scope for being open to fine-tuning changes over the subsequent 12 months or so, should have been greater.

• Teachers expressed frustration at not being communicated updates around actions or requests taken forward from moderation meetings. Perhaps a newsletter report a couple of times per year could be issued from CS. This would give feedback to teaching staff. This is particularly important because teaching staff help develop courses and give feedback without compensation unlike many other jurisdictions.

• Issues identified around scope of the course which currently has a very broad enrolment from students possessing the full spectrum of academic ability and sport, recreational or outdoor activity focus. Perhaps the course being so broad does not cater for any single group in an optimal way.
