- response to concerns raised in March 2019 report:

Year 11/12 extension schools and Academic Integrity.

Janine met with Marie Phillips (Project Manager, Years 11 and 12 Expansion and two of her team). Thanked for noting a concern.

Way forward: Opportunity for Library group leadership in area. Look at purpose of these meetings, and next year use this time to moderate Al, and make this clear on registration form, to encourage extension school participation. Moderation from work samples from other subjects. Use meeting to model expectations. Explore partnerships between Sen Sec and extension schools. If none attended, they could use the archive of moderated resources. Curriculum Services will identify courses to source work samples for Al moderation. Pre-submit ratings as per processes in all moderation meetings, reasonable number of work samples. Each course already has Al standards specified within the criterion standards for the course.

Could record the discussion. Or PowerPoint presentation as a learning tool. Get participating teachers' concerns tabled. This would be an opportunity to build capacity.

Concern was also re resourcing, not just Al. Resourcing is a school issue, not a moderation issue.

Options for proceeding were discussed and it was agreed to meet either in person on Friday 22 November in Campbell Town (funding permitting) or via Skype to clarify processes for March including obtaining work samples. Virtual Learning Tasmania to be invited.

Northern Moderation Leader will look at 2018 Assessment reports on folio subjects and create a briefing paper identifying issues.

3. Academic Integrity:

Revised document has been submitted to TASC March 2018, then March 2019 follow up meeting. The document was well received by TASC, who advised that the recommendations will be part of the major changes at TASC re website etc. No timeline.

Main suggestions to Al document changes: Add MLA as a referencing style, but don't specify editions. Refer to University of Tasmania, not UTAS acronym. Terminology Style not system, remove multiple pages re referencing examples, no hyperlinks as these become obsolete over time.

Suggestion that we suggest a deadline for the Academic Integrity document revisions to be finalised, and accepted by TASC. Review November meeting and then at March 2020 Moderation. Stacey to contact Curriculum Leader (Mixed Field and other) about involvement.

4. Canvas Al module

Isobel, Kate and Karen have looked at the Al Module. Changes needed are linked to Al guide. Ongoing. Will set themselves a deadline and meet by email. They will report back in March meeting.

More time consuming. Unable to download to hard copy from Exchange. All Southern and two Northern users (at this meeting). Argue cost of the resource with Clickview - cut a deal?

- b. Cataloguing resources Web Dewey no longer print edition. OCLC (Online Computer Library Center): is now offering print on demand. Only 4 volumes, twice per year, Jan and July. Through Amazon.com.au Pricing is around \$700-\$800
- c. English and promoting reading culture amongst students English 3 and Lit 3. Query re English 3 Adaptation Study (Module 2) and copyright by specifying the article "The Orchid Fever" which is available online. The site has a copyright claim "The material on this site may not be reproduced, distributed, transmitted, cached or otherwise used, except with the prior written permission of Condé Nast." Alert English 3 staff to their AI responsibilities.
